PLEASE READ:
• The futurity committee reserved the right to refuse and stallion
• Stallion's service must sell to allow the stallion's owner the privilege of participating in this futurity, subject to the same rules and conditions as the service purchaser.
• Rules to this futurity are attached to this agreement. Please read and keep these rules for future reference.
• Minimum bid at the auction will be \$200 or 1/2 the usual advertised fee, whichever is greater, plus \$50.
• Stallion owner wishing to guarantee the sale of service may enclose a check for minimum bid or greater, plus \$50, with agreement, payable to MN Select Futurity.
• Photocopy of Stallions Registration papers is required as part of this agreement.
• Fee must be your highest advertised fee for this auction year.
• If shipped semen permit is held on stallion, shipped semen must be available for futurity breeding purchased in this auction.
• Return breeding privilege for reclassified mares will follow MPHA Select Futurity Rules and same conditions as stated on this contract.
• NO PRIVATE TREATY ACCEPTED!!
• NO FUTURITY ONLY SPECIALS!!
• NO CHUTE FEES!!

All parties to this agreement are BOUND to all AGREE to all of the following:
1. AQHA and TB Stallions must be listed with APHA ( contact APHA for listing forms) and must be in good standing with APHA.
2. Service may only be used on Registered APHA, AQHA or TB mare.
3. Mare must be broke to lead and tie.
4. Mare must be in good conditions and health. Stallion Owner may REQUIRE health papers on the mare.
5. Stallion Owner has the right to call a veterinarian when they deem necessary, at the Mare Owner's expense.
6. Stallion Owner is to see that mare and foal are properly taken care at all times while in the Stallion Owner's care.
7. Mare Owner will pay board to Stallion Owner at their advertised rates.
8. All agreements, including shipped semen, are between the Mare and Stallion Owner. MNNESOTA PAINT HORSE ASSOCATION and The MINNESOTA SELECT FUTURITY COMMITTEE act as agent only.
9. Stallion Owner may REQUIRE Mare Owner to sign Farm or Ranch breeding contract, A copy which must accompany this agreement. Any additional fees to Mare Owner must be stated on this agreement.
