- \$5 Weanling Nomination Due Feb. 15 or prior to birth (unborn before May 31, see Rule III 3a)
- \$70 **Early Bird** payment will be accepted if paid by May 1. No subsequent sustaining payments needed.  
If paying a weanling as early bird, please remember to foal ID by Aug. 1st or there is a \$20 late fee.  
**No foal ID's allowed after September 1st.**
- \$30 First Sustaining Payment Due by June 1st (After June 1st add \$20 late fee)
- \$30 Second Sustaining Payment Due by July 1st (After July 1st add \$20 late fee)
- \$30 Third Sustaining Payment Due by August 1st (After August 1st and before September 1st add \$50 late fee  
plus all missing late sustaining payments.)
- \$35 Hardship fee for horses not nominated in their weanling year. (see Rule III 4.)

Payments accepted after September 1st would need to include all sustaining payments, applicable late fees, plus \$100, up until the futurity date but prior to the start of the show.
